- I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- 3. I willingly agree to comply with the state and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,

I HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE THE ORIGINAL SPORT LLC, EVOLUTIUON ATHLETIC CLUB (AND EACH OF THEIR RESPECTIVE AFFILIATES, ADMINISTRATORS, DESIGNEES, LICENSEES, AGENTS, COACHES, OFFICERS, DIRECTORS AND EMPLOYEES), OTHER PARTICIPANTS, OPERATIORS, VENDORS, SPONSORING AGENCIES, SPONSORS, ADVERTISERS, AND OWNERS AND LESSEES OF PREMISES USED IN CONNECTION WITH AN EVENT ("RELEASEES") WTH RESPECT TO ANY AND ALL INJURY, DISABILITY DEATH OR LOSS OR DAMAGE TO PERSON OR PROPERTY ASSOCIATED WITH MY PRESENCE OR PARTICIPATION, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW;

  TO MY PARTICIPATION IN OR OTHERWISE IN CONNECTION WITH THE
  EVENT, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR
  OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.
- 6. I am responsible for all property I bring into The Original Sport LLC d/b/a Evolution Athletics Club premises and facilities, and I agree that the Releasees shall have no responsibility for any loss or damage to my property.
- 7. I expressly agree that (a) this **RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT** is governed by the laws of the State of Connecticut, USA and is intended to be as broad

and inclusive as is permitted by Connecticut law, and that if any portion hereof is held invalid it is agreed that the balance shall nonetheless continue to full legal force and effect; and (b) for the purposes of any action or proceeding arising out of or related to this **RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**, I expressly submit to the jurisdiction of all federal and state courts located in the State of Connecticut.
